





The saving if any, after meeting the recurring and non – recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further, utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo, or any other nonacademic activities to any other institution organization or body.
6. That the school will not open classes under CBSE pattern particularly class ix/x/xi/xii and will not use CBSE name any manner without obtaining affiliation.
7. That the principal and correspondent / Manager of the school have individually gone through the provisions contained in the affiliation & examination Byelaws and the circulars issued by the Board from time to time. 
